Curcuminoids are well-known antioxidants and have been traditionally used to support joint, gut, and liver health. Livinol:

Prepared from kokum fruit (*Garcinia indica*) and is standardized for 20% garcinol. Traditionally its juice is used as a natural remedy for the stomach and liver ailments. Garcinol is an excellent source of antioxidants and offers multiple health benefits including for the heart, gut, and liver.



BioPerine:
